第一條 依據

依據本校『教師聘任升等辦法』訂定「創新科技應用於生物醫學暨醫療照護產品研發國際博士學位學程(以下稱本學程)教師升等審查辦法』(以下稱本辦法)。

Article 1 Regulation Basis

The regulations governing the faculty member promotion review for the International Ph.D. Program of Innovative Technology of Biomedical Engineering and Medical Devices of MCUT (hereinafter referred to as the Ph.D. Program) (hereinafter referred to as the Regulations) is hereby formulated in accordance with the University's "Regulations Governing Teachers' Appointment and Promotion".

第二條 申請條件

本學程專任教師需符合以下規定,方得提出升等申請:

- 一、於本學程服務滿一年以上。
- 二、符合本校「教師聘任升等辦法」教師升等規定。
- 三、符合教育人員任用條例之相關升等資格規定。
- 四、符合本校「教師升等教學、服務與輔導成績考核細則」 成績規定

Article 1 Regulation Basis

Full-time faculty members of the PhD. Program shall meet the following rules before submitting the promotion application:

1. Serve the Ph.D. Program for more than one year.

- 2. In line with the University's rules for a faculty member's promotion as provided in "Regulations Governing Teachers' Appointment and Promotion".
- 3. Comply with the relevant promotion eligibility requirements of the Educators Appointment Act.
- 4. Comply with the University's rules for scores as contained in the "Assessment of Teachers' Grades in Teaching, Service and Counseling Performance."

第三條 升等門檻

- 一、以研究成果升等之教師,依本辦法第四條規定計算積分,代表著作應為送審人取得前一等級教師資格後及送審前五年內之著作;參考著作應為送審人取得前一等級教師資格後及送審前七年內之著作。但送審人曾於前述期限內懷孕或生產者,得申請延長前述年限兩年。上述期間所從事之研究成果積分要求需符合下列條件:
 - (一)升等助理教授需為 150 分以上。
 - (二)升等副教授需為250分以上。
 - (三)升等教授需為350分以上。
- 二、以技術報告、教學表現或產學表現升等之教師,升等門 檻依照「工程學院教師升等審查辦法」。

Article 3 Promotion Threshold

1. Faculty members to be promoted based on research achievement whose credits shall be calculated in line with Article 4 of the Regulations. Their representative works should be those submitted for review within the past five years after obtaining the faculty member qualification of the previous level and before submission for review; the reference works should be those submitted for review within the past seven years after obtaining the faculty member qualification of the previous level and before submission for review. However, if the applicant has been pregnant or has given birth within the aforesaid period, she may apply for an extension of the aforesaid period for two years. Research achievement credits during the above period must meet the following requirements:

- (1) Promotion to assistant professor requires 150 points or more.
- (2) Promotion to associate professor requires 250 points or more.
- (3) Promotion to professor requires 350 or more.
- 2. Faculty members to be promoted based on technical reports, teaching performance, or academic performance shall be subject to the promotion threshold as provided in the "Regulations Governing the Review of Teacher Promotion of Engineering College."

第四條研究成果積分

教師研究成果積分計算標準如下:

- 一、專利一發明專利,每件30分,新型專利,每件5分。
- 二、比賽—參與國際比賽第一名30分,第二名25分,第三名20分,佳作15分;參與全國性比賽第一名20分,第二名15分,第三名10分,佳作5分,若相關比賽以等第或其他方式代替名次,則由申請教師提出相關說明,由教師評審委員會議認定。
- 三、國際 SCI 級學術期刊論文—第一作者或通訊作者 30 分, 第二作者 20 分,第三作者 10 分,其餘不計分。
- 四、國際非 SCI 級學術期刊論文—第一作者或通訊作者 15 分,第二作者 10 分,第三作者 5 分,其餘不計分。
- 五、國際學術會議論文—第一作者或通訊作者8分,第二作者 6分,其餘不計分。
- 六、產學合作案—50 萬元以上 30 分,50 萬元以下 30 萬元以 上 20 分,30 萬元以下 10 分。
- 七、執行科技部計畫案或政府機關委託之計畫案(需為計畫 主持人),一案30分(若為多年期計畫,以每年一案做計 算)。
- 八、國內具審查機制之期刊論文—第一作者或通訊作者5分, 第二作者3分,其餘不計分。
- 九、國內學術會議論文—第一作者或通訊作者4分,第二作者 2分,其餘不計分。

Article 4 Research Achievement Credits

The calculation criteria for research achievement credits are as follows:

- 1. Patent: A patent for invention is equivalent to 30 points, and a utility model is equivalent to 5 points.
- 2. Competition: For an international competition, 30 points is given for the first place, 25 points for the second place, 20 points for the third place, and 15 points for excellent works. For a national competition, 20 points is given for the first place, 15 points for the second place, 10 points for the third place, and 5 points for excellent works. If the competition uses grade or other means to replace the ranking system, the applicant shall submit relevant explanations, which shall later be evaluated during the Faculty Evaluation Committee Meeting.
- 3. International SCI-level academic journal papers: 30 points for the primary or corresponding author, 20 points for the second author, 10 points for the third author, and no point for the rest of the authors.
- 4. International non-SCI academic journal papers: 15 points for the primary or corresponding author, 10 points for the second author, 5 points for the third author, and no point for the rest of the authors.
- 5. International academic conference paper: 8 points for the primary or corresponding author, 6 points for the second author, and no point for the rest of the authors
- 6. Industry-university cooperation project: 30 points for a project amounting to NT\$500,000, 20 points for a project amounting between NT\$300,000 and NT\$500,000, and 10 points for a project amounting below NT\$300,000.
- 7. Projects of the Ministry of Science and Technology or projects entrusted by the government authorities (the applicant need to be the project initiator): 30 points for implementing one project (a multi-year project shall be calculated as one case for each year).
- 8. Domestic journal papers with a review mechanism: 5 points for the primary or corresponding author, 3 points for the second

author, and no point for the rest of the authors.

9. Domestic academic conference paper: 4 points for the primary or corresponding author, 2 points for the second author, and no point for the rest of the authors.

第五條 教師升等審查程序

申請教師準備相關資料送本學程主任確認符合第二條各款及第三條之規定後,始可送學程教師評審委員會審查,經學程教師評審委員會議出席委員三分之二以上通過,申請人依審查意見修正後,送院、校教評會審議。

Article 5 Procedures for the Faculty Member Promotion Review

The applicant shall prepare relevant materials and submit them to the Ph.D. Program Director to confirm whether they are in line with paragraphs of Articles 2 and 3 before submitting them to the Ph.D. Program Faculty Evaluation Committee for review. With the consent of more than 2/3 of the committee members present, the applicant shall amend them based on the review opinions and submit them to the College/University Faculty Evaluation Committee for review.

第六條 未盡事宜

本辦法未盡事宜悉依相關法令及本校相關規章辦理。

Article 6 Matters Not Covered

Matters not covered herein shall be subject to relevant laws and relevant regulations of the University.

第七條 實施與修訂

本辦法經院務會議通過,陳校長核定後公布實施,修訂時亦同。

Article 7 Implementation and amendments

The Regulations shall be implemented upon endorsement by and at the College Council Meeting and presented to the President for approval. The same shall apply to any amendments.

- 7. Projects of the Ministry of Science and Technology or projects entrusted by the government authorities (the applicant need to be the project initiator): 30 points for implementing one project (a multi-year project shall be calculated as one case for each year).
- 8. Domestic journal papers with a review mechanism: 5 points for the primary or corresponding author, 3 points for the second author, and no point for the rest of the authors.
 Domestic academic conference paper: 4 points for the primary or corresponding author, 2 points for the second author, and no point for the rest of the authors.
